

Privacy Policy

The Hideaway Solutions Privacy Policy was updated on May 21st, 2019

This Privacy Policy describes the types of information we collect through our website, how and when we share that information, your options for sharing your information, and our practices for protecting that information.

By accessing or using our website or giving us personally identifiable information you agree to this Privacy Policy and consent to our collection, use, and disclosure of your personally identifiable information as set forth herein.

Information We Collect from You

It is always your choice whether you wish to provide personally identifiable information through this Website; however, if you do not provide the requested personally identifiable information, you may not be able to use certain features or functionalities of the Website.

We may collect personally identifiable information (e.g. your full name, email address, mailing address, telephone number, and/or credit card number) from you when you voluntarily submit the information to us when using our Website. We need this information in order to process and fulfill your order and to notify you of your order status, register you as a user of this site or provide you with services. For instance, we may disclose your personally identifiable information to our third party service providers who provide services such as website hosting, data storage, data analysis, payment processing, order fulfillment, IT services and infrastructure, customer service, email delivery and administration, credit card processing, auditing and other similar services to enable them to provide services to us or on our behalf.

We may also collect personally identifiable information from you if you choose to register on our Website, subscribe to our email program, mailing list, enter the information into the shopping cart, or participate in contests, and surveys, or in connection with content or suggestions you post on this Website. We also collect non-personally identifiable information (e.g. interests, lifestyle choices, opinions) from you when you choose to provide or post non-personally identifiable information on this website, or via participation in our email program, contests, surveys or content or suggestions you post on this site.

Non-personally identifiable information may also be collected from you by means of Cookies and Pixel Tags. Cookies are small bits of information that this website places on your computer. We and our third party service providers use cookies and Pixel Tags to identify your IP address, browser type, domain name, and specific web pages through which you click. This data is collected automatically and utilized to help us look for trends to improve our Website and your interactive experience. The cookies that are configured by this Website do not contain any personally identifying information, such as your name, or sensitive information, such as your credit card number.

When Hideaway Solutions conducts contests, promotions and surveys, or joins with other companies to do so, if you choose to participate you may be asked to provide personal information. Hideaway Solutions and the other participating companies may use this information for such purposes as notifying winners and fulfilling promotional obligations, and may also cross reference customer databases to identify common customers. Information from these activities may be used to explore future promotional opportunities or fulfill contractual obligations. In addition to the above, we may share your information if required to comply with a law, regulation, court order or legal process, or if we believe it is necessary to share such information with a government entity or to enforce or apply our Policies (Terms of Use). We may share information to protect our rights or property or if the rights of any third party are jeopardized.

Choices for Opting-in and Opting-out

We and/or our third party marketing partners may contact you and market to you, including by mail, Internet connection, text, telephone, fax or email, consistent with this Privacy Policy. In each of our email and texting marketing communications, we will allow you to opt out of future mail and texting marketing communications. Participation in certain of our programs will require you to accept email communications regarding the program itself. You may opt-out of receiving email and texting communications by

clicking the "Unsubscribe" link at the bottom of the email or text message received. It may take us up to ten (10) days to complete this process, as permitted by law.

We may use the services of third parties to collect and use anonymous information about your visits to and interactions with our website through the use of technologies such as cookies to personalize advertisements for goods and services. We will try to comply with your request(s) as soon as reasonably practicable. Please also note that if you do opt-out of receiving marketing-related messages from us, we may still send important administrative messages to you, and you cannot opt-out from receiving such administrative messages. For example, when you place an order, we will continue to confirm your order and shipment status by email. We may also need to contact you via telephone, email or postal mail with information or questions regarding your order.

Aggregated Information

We and our service providers may aggregate personally identifiable information collected from our customers and potential customers, for example by using personally identifiable information to calculate the percentage of such individuals who have a particular telephone area code. Aggregated personally identifiable information does not personally identify you or any other customer or potential customer, and such aggregated personally identifiable information is an asset of ours and belongs to us.

Security

We use reasonable efforts to protect our customers' information.

When our registration/order form asks customers to enter sensitive information (such as credit card number), that information is encrypted and is protected using Secure Socket Layer (SSL) technology.

The safety and security of your information also depends on you. Where we have given you, or where you have chosen, a password for accessing the Website, you are responsible for keeping such password confidential. If you are sharing information in public areas, like message boards, we urge you to be careful about the type of information you provide as it may be viewed by any user of the Website.

The transmission of information via the internet is not completely secure. Although we use reasonable efforts to protect your personally identifiable information, we cannot guarantee the security of your personally identifiable information transmitted to our Website. Any transmission of personally identifiable information is at your own risk.

Privacy on Other Sites
